

G. O. P. STILL HAMMERING WILSON MEXICAN POLICY

WASHINGTON, Aug. 26 .- The Administration's Mexican policy was attacked in the Senate today by Senator Lippitt,

in the Senate today by Senator Lippitt, Republican, who said the "unforgivable thing" was the lifting of the embargo on arms in February, 1914.

"Mr. Wilson could not have been in ignorance of the horrible deeds his action in lifting the embargo would cause," said the Rhode Island Senator. "It was not done impulsively as the result of a crisis. A policy had failed, so President Wilson, whose campaign cry is that he has kept the country out of war, used as an instrument the most horrible and indefensible kind of warfare, and all the forces of murder, robbery, unbridled passion and lust were armed and encouraged to conduct a conflict in which nothing was sacred, not even the altar of religion."

WASHINGTON, Aug. 26.—The American Red Cross announced tonight that fifty-five of its most expert nurses had been sent to the border for duty with the troops and that additional groups were ready to go as soon as the War Department designates places for them. The Department recently asked the organization to choose 100 nurses for border service.
