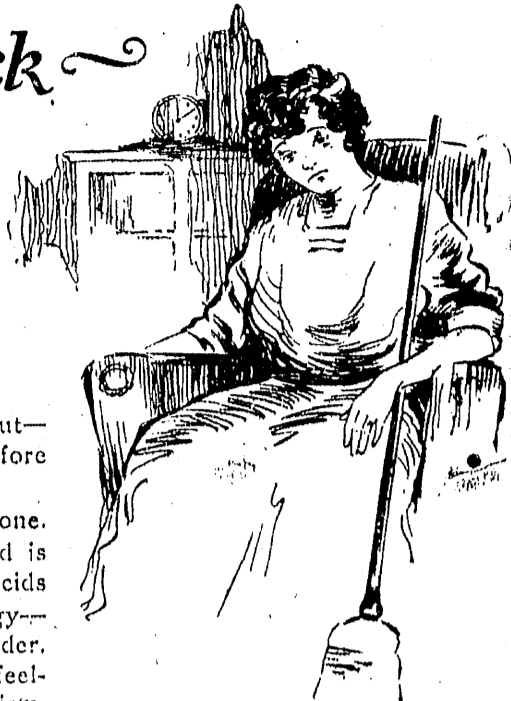


STUDY WINDOW SHOPPERS
 BERLIN Germany, April 16.—An Ex-
 periment recently made a study of the
 psychology of window dressing and
 kept a record of the manner in which
 crowds look at show windows.
 This disclosed that 648 persons
 looked at the bottom of the display,
 411 looked at the center of the win-
 dow, 188 persons looked at the left

side, 177 at the right side, and 67
 window during the observation, 219
 at the top. Of those who passed the
