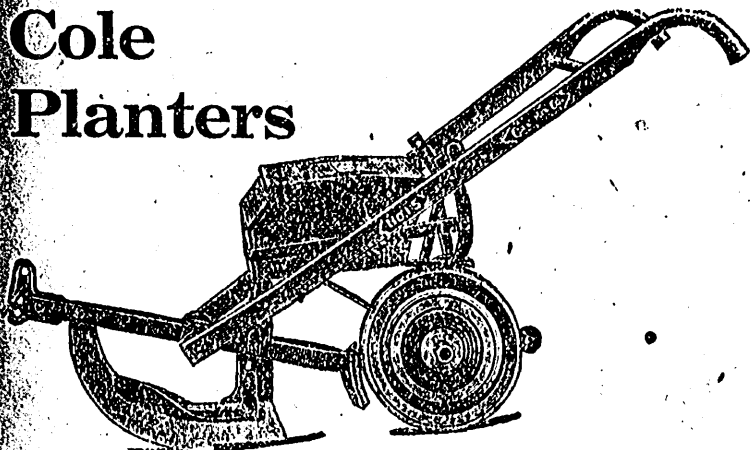

GOBER HEADS KNIGHTS OF PYTHIAS OF STATE

GRAND LODGE IN SESSION IN CAPITAL

Next Convention Will Be Held in St. Augustine—Pythian Sisters Also Meet

TALLAHASSEE, March 13.—(Special)—The next annual meeting of the grand lodge knights of Pythias of Florida will take place in St. Augustine, the second Wednesday in April, 1920. At its business session this morning in the local Pythian Castle hall, the following officers were elected to serve during the coming year: Grand chancellor, William M. Gober of Lakeland; grand vice-chancellor, Dr. W. S. Coffee of Arcadia; grand prolate, W. B. Crawford of Kissimmee; grand keeper of records and seal, J. G. "BORROWED" AUTOMOBILE AND DITCHED IT

Fine Residence Sold; "Baby Sue" Elephant to Solicit for Salvation Army—Night Concerts

ST. PETERSBURG, March 13.—(Special)—Three youths who "borrowed" an automobile belonging to Lester Harvey, taking it from in front of the Plaza theater one evening last week. The three are well known here, and belong to good families so Judge Maurer, of the municipal court, held up the jail sentences of all three to the next week. The guardians of the boys are to be in court and show why they have not controlled the youths. The three are Milton Knipp, Harry Nattson and Roger Randall. They abandoned the automobile after it had stuck in a ditch near Coffee Pot avenue. Several automobiles have been taken by joy riders lately and Chief of Police J. Easters offered a reward of \$50 for information leading to the arrest of the thieves. L. B. Stout, formerly a city detective, gave the information on which the arrests were made and will get the reward offered. The youths went to jail unable to pay the fines imposed.

Charles S. Jopp, a retired banker of Winsted, Conn., has closed a deal for the attractive residence of No. 549 Eighth avenue north, which was owned by C. D.
